

ICEX Spain and Indian School of Hospitality partner to enhance hospitality education and cultural exchange

India hosted the International Conference on Green Hydrogen (ICGH-2023) in New Delhi

The Government of India had earlier announced the launch of the National Green Hydrogen Mission, aiming to achieve the country's net-zero target by 2070. As part of this Mission, India organised the International Conference on Green Hydrogen (ICGH-2023) from July 5th to 7th, 2023, in New Delhi.

The three-day conference brought together global scientific and industrial communities to discuss recent advancements and upcoming technologies in the green hydrogen sector. It featured plenary sessions, expert panel discussions, and technical deliberations focused on establishing a green hydrogen ecosystem and catalysing India's goal of producing 5 million metric tons of green hydrogen by 2030.

In addition to exploring hydrogen production, storage, distribution, and downstream applications, the conference addressed topics such as green financing, human resource growth, and start-up initiatives. The main aim of ICGH-2023 was to foster collaboration and innovation through global networks, paving the way for India's sustainable and clean energy future.

Report released by the Swedish Enterprise shows positive growth in India-EU relations by 2030
